#### I. Welcome and Introduction

### II. Minutes

## **III.** Committee Reports

**Treasurer's report** - Randy Behney handed out copies of the budget. Copy of the budget is attached. Motion by Randy Rich and seconded by Tom Farr to accept the budget. Budget was approved. Randy then reviewed the Treasurer's report and a copy is attached. Motion by Dave Hartlaub and seconded by Mike Lorback to accept the report. Treasurer's report was approved.

Due to the large amount of money in the savings account, a motion was made by Mike Lorback and seconded by Randy Rich to invest \$20,000.00 in a higher interest account. Motion passed. Randy Behney discussed banquet. A motion to book the Park Inn for January 26, 2013 was made and passed. It was discussed to bring up the All-State players first and then All-Region players and then All-American players and then the Player of the Year. Randy will look into this procedure.

### Membership/Website/Sponsorship

*Sponsorships* Tony stated that the sponsorships will remain the same.

Website The website is going very well. There is a fan page on Facebook and PSCA also has a Twitter account.

**Statistics** Pat Birns gave a report on the blue jeans program which is the first step for updating the statistics. Pat said the next step is a mobile application which would allow the league reps to handle more of the statistical input. A motion by Randy Behney and seconded by Mike Lorback to allow Pat to spend from \$700 to \$1400 on this next step. Motion passed.

### All-State and All-American

**Boys and Girls** Brandon Ramsey and Keith Nagley gave their reports. The biggest problem is still late paperwork. Coaches' names will be added to the All-State form so the chairman can get in touch with them when needed.

**Coach of the Year** Scott Bonagura gave his report. The biggest problem is the date to have the names turned in has been moved to November 9 and leaves very little time.

**Liaison Committee** Pat Birns attended the PIAA steering committee. Major changes – PIAA will keep the *white uniform rule* but will allow the schools to get a waiver if money is not available to purchase new uniforms. *Mercy rule* – running clock after seven goal differential. *Overtime rule* – back to 15 minutes. A letter will be sent out to get coaches' input on rule changes.

**Hall of Fame, Honor Award, and Service Award Committee:** To get names of more people, nominations will be mentioned in the newsletter that is sent out to the membership.
