I. Welcome and Introduction

After the official changing of the gavel, President Mike Lorback called meeting to order at 5:00 pm.

II. Minutes

Minutes were presented from last year's meeting in Harrisburg at the Park Inn on January 12, 2012. The minutes were submitted for the Indianapolis meeting held on January 19, 2013. Minutes were taken by Mike Lorback due to Rob Burcik's absence. . Motion to accept the minutes by Glenn Hibshman and seconded by Dave Hartlaub. Motion passed.

III. Committee Reports

Treasurer's report - Randy Behney handed out copies of the budget. Copy of the budget is attached. Motion by Glenn H. and seconded by Randy Rich to accept the budget. Budget was approved with possible changes in later discussions.. Randy then reviewed the Treasurer's report and a copy is attached. One major change was increasing dues to \$12,525 because of increase of coaches due to the girls' program going to the fall. Motion by Dave Hartlaub and seconded by Rob Burcik to accept the report. Treasurer's report was approved.

Randy Behney discussed banquet. A discussion regarding booking the Park Inn for January 25, 2014 took place. There is a 95% chance that we will stay at the Park Inn. Randy will update when he gets all the information. It was discussed to have the All-State players email a photo to Scott so that a slide show could be made for people to watch before the banquet. Also, it will be looked into seeing if the photographer could take individual pictures of the All-State players in front of the sponsors' signs and post them on his website for purchase.

Membership/Website/Sponsorship

Membership Tony Cavallaro gave the membership list in each category. Total was approximately 800. Tony wanted to send out three mailers or newsletters to members and Athletic Directors indicating member benefits and an invitation to the general meeting at NSCAA convention. Also, this brochure could also be put in the NSCAA convention packet.

Sponsorships Tony stated that the sponsorships will remain the same. Randy Rich will look into getting Comcast to become a sponsor.

Website The website is going very well. There is a fan page on Facebook and PSCA also has a Twitter account. Tony will look into using more forms on-line to eliminate paperwork.

Statistics Pat gave his statistics report. Only 10 girls' leagues and 12 boys' leagues updated this year with the new system compared to 20 and 24 respectively last year. The next step to upgrade the statistics will be about \$1,000. Money was already budgeted to cover this expense. Pat also stated that the end of the year records are still important to turn in since this is how the schools' and coaches' overall records are updated.

All-State and All-American

Boys and Girls Brandon Ramsey and Keith Nagley gave their reports. There were 68 All-State Boys, 17 All-Region Boys, and 3 All-American Boys. There were 75 All-State girls, 15 All-Region girls, and 3 All-American girls. We lost 1 All-American selection in both boys and girls because of a decrease in NSCA membership. The major change that both Keith and Brandon would like to make is to do more on-line submissions to cut down on paperwork. Patrick is going to look into this possibility.

Coach of the Year Scott Bonagura gave his report. The biggest problem remains the date to have the names turned in has been moved to November 9 and leaves very little time. At that point, we are only to the quarter finals of states. Scott is going to look into waiting so we can get the state championship coaches into the selection process. The problem with parochial and private school divisions in the NSCAA was discussed since Pennsylvania does not separate the private schools in the playoffs.

Liaison Committee No report due to no meeting. .

Hall of Fame, Honor Award, and Service Award Committee: To get names of more people, nominations will be mentioned in the newsletter that is sent out to the membership. Also, try to get nominees from other parts of the state which are not represented on the executive council.

Boys Glenn Hibshman read his report. Mike Lorback is looking for more input from areas that are not represented. Use league websites to obtain information

Girls Dan Hogan gave the girls' report. Everything was the same report as the boys'.

New Business 1.) Next meeting dates--(a) NSCAA convention on January 15-19, 2014 in Philadelphia, PA. Saturday at 4:00 pm meeting, 5:30pm social-off site to be determined by Mike (b) PSCA annual meeting after the All-State banquet, January 25, 2014 most likely at the Park Inn. 2) Share the Wealth Program-- \$518 was raised from the raffle. Gerald Botdorf was having problems with shipping to South Africa. He is looking to ship to Honduras. Right now Gerald has enough money to take care of shipping costs. 3.) Robbie Robinson Foundation--Tom Farr brought up the possibility of donating to the Robbie Robinson Foundation. A handout was reviewed. After discussion, motion by Rob Burcik, seconded by Glenn Hibshman for a one-time \$1,000 donation was made. Motion passed 13-1.

4) Social Media--Send any information to Dan Hogan to be placed on our Facebook page. Our Facebook and Twitter accounts will be listed on the newsletter so more people know about the sites. 5) Player milestone recognition was brought up by Keith Nagley. Keith feels we should recognize players who break records; such as the girl who broke the career goal scoring record. They will look into

having a certificate that can be downloaded from the website. Also, they would like to recognize the referee of the year at the banquet if the State Referees Association makes such a selection. Finally, invite Mark Byers from the PIAA to the banquet. Motion made by Randy Rich and seconded by Tony Cavallaro. Motion passed. 6.) Partnership between NSCAA and EPYSA were brought up by Mike Lorback. Mike handed out two agreements; one from NSCAA and one from EPYSA to form partnerships. The partnership with EPYSA would be agreed to if T3 Camps agrees. Motion was made by Randy Behney and seconded by Glenn Hibshman. Motion passed. NSCAA partnership was explained and discussed. Motion by Tony and seconded by Bob Black to accept the partnership. Motion passed. 7.) Motion by Mike Lorback and seconded by Glenn Hibshman to elect Bob Black as second vice president. Motion passed.

Meeting was adjourned at 9:00pm by President Mike Lorback.
